APRIL 4-5, 2025 - Winnemucca Events Center – Exhibit Hall – 1000 Fairgrounds Rd., Winnemucca, NV 89445

(1) MAXIUM 2 ARTISTS PER BOOTH

(2) HEALTH DEPT REQUIREMENTS: A) Pay HEALTH FEE Per-booth (10x10) prior to show (\$100), (B) Have CURRENT HEALTH DEPT LICENSE from your home county, (C) Have BLOOD-BORNE PATHOGENS training certificate.

(3) USE DISPOSABLE TATTOOING/PIERCING EQUIPMENT

(4) NO LOUD MUSIC. NO FOOD/DRINKS INSIDE TATTOOING BOOTHS.

MOVE-IN TIME THUR. APR. 3<sup>RD</sup> 10am – 5pm (there are several doors and a loading door)

SHOW HOURS FRI. APR. 4<sup>TH</sup> 10am – 9pm, SAT. APR. 5<sup>TH</sup> 10am – 9pm (stop work 1 hour before closing)

(DOORS LOCKED UP BY 10PM) (no early move out)

MOVE-OUT TIME SUN. APR. 6<sup>TH</sup> 10am – 2pm (\$500/hour late charge after 2:30pm)

**BOOTH PACKAGE** Booth package: 1 skirted table, 1 plain table, 2 chairs, 1 sign, 2 trashcans, and 3 wristbands.

WRISTBANDS Additional/Replacement wristband \$20 each. No sharing or selling wristbands. You will lose your

wristband if it is cut, taped, or tampered with.

HEALTH REG: WEAR YOUR WRISTBAND ON YOUR NON-TATTOOING WRIST ONLY.

WHAT TO BRING Electrical cords, surge protectors, extra tables, chairs, tables cloths, arm rests, etc.

\*\*MUST HAVE BIOHAZARD SHARPS CONTAINER FOR NEEDLE AND CARTRIDGE DISPOSAL.

(BRING 1 PER ARTIST) (these will be collected at the end of the show on Saturday night)

SHOW RULES No Balloons, No Helium Tanks, No Megaphone, No Loud Music. No selling or distributing food or drinks of

any kind.

FOOD VENDORS All food or beverage vendors must be pre-approved. Food samplings must be less than 1 ounce and be

pre-approved.

GENERAL VENDORS Bring your own tables, chairs, canopy, cords, etc. set up in meeting room.

FOOD TRUCKS Must have health permits and event permits. Please have seating available if possible. A 12% fee will be

due to WDVA.

HEALTH DEPT. REQUIREMENTS Humboldt County Health Department regulations governing tattoo/piercing shops:

1) EACH ARTIST MUST HAVE A CURRENT BLOOD BORNE PATHOGEN TRAINING CERTIFICATE

2) EACH TATTOOING/PIERCING BOOTH MUST HAVE:

a. A WRITTEN EXPOSURE CONTROL PLAN

b. AFTER CARE FORMS FOR CLIENTS

c. CLIENT RELEASE FORMS (ON ALL FORMS YOU MUST INCLUDE)

i. COPY OF CLIENT ID

ii. NEEDLE/CARTRIDGE LOT #, EXPIRATION #, SIZE OF ALL USED

iii. BRAND OF INK USED AND ALL COLORS

3) NO FOOD OR DRINKS ALLOWED INSIDE BOOTH AT ALL TIMES

4) NO ONE UNDER 18 SHALL BE ALLOWED IN A BODY ART WORKSTATION FOR ANY KIND OF TATTOOING.

5) NO ONE UNDER 16 SHALL BE ALLOWED TO GET PIERCINGS. MINORS ABOVE 16 MAY GET BODY PIERCINGS IF ACCOMPANIED BY AND HAVE WRITTEN CONSENT BY THE PARENT OR LEGAL GUARDIAN.

6) CLIENT CHAIR/TABLE MUST BE WIPED DOWN WITH AN EPA REGISTERED DISINFECTANT USINGA A SINGLE-USE PAPER TOWEL BEFORE AND AFTER EACH CLIENT.

7) ALL USED NEEDLES MUST BE DISPOSED OF INTO APPROVED SHARPS CONTAINERS.

8) ALL TATTOOING/PIERCING EQUIPMENT MUST BE STERILIZED or DISPOSABLE TYPE.

**HEALTH LICENSE FEE** – MUST BE PAID IN ADVANCE ONLINE

NV-\$125 Event Fee

NO SCRATCHERS: MUST HAVE AT LEAST 3 YRS OF EXPERIENCE WORKING IN A LICENSED SHOP. NO SCRATCHERS ALLOWED.

INDUSTY PRICING Charge standard industry minimum pricing such as \$50 for piercing, \$100 tattooing.

TATTOO KITS Do not sell tattooing kits/equipment to non-industry/non-certified customers.
