

**TWISTED GOLD TATTOO CONVENTION™ CONTRACT V.2025**

Twisted Gold herein referred to as Management and Vendor/Artist herein referred to as Exhibitor is required to obtain all required license(s), permit(s), and to collect and report all sales tax generated at the show as required by local and/or state governmental agencies. Exhibitors must abide by the published schedule of show hours, move-in and move out times and may not terminate his/her exhibit early. Exhibitor must occupy his/her boot at least one hour prior to the opening of the show; otherwise, Management may relocate or cancel Exhibitor's booth without further notice and with no refund or exchange. Management assumes no responsibility and liability for any merchandise or exhibit left in exhibit hall beyond the move-out time and an overtime charge of \$500 per hour will apply. It is Exhibitor's sole responsibility to leave the rented space in its original condition, otherwise Management will charge a trash removal/damage/repair fee of at least \$200. Exhibitor must have liability insurance and be responsible for his/her own action and/or liability resulting from the operation of his/her exhibit. The exhibitor is liable for any and all liability inside as well as five feet away from his/her booth. Exhibitors must abide by all City, County, and State laws regulating tattooing and piercing. Management prohibits any and all illegal activities. The exhibitor agrees to hold Management harmless any and all liabilities arising from the operation of the exhibit or products being sold during the show. Management will not be held responsible for any loss of property due to theft, fire, accident, or other causes. Exhibit space cannot be picked or assigned, until payment is received in full. Management reserves the right to cancel the Exhibitors contract and forfeit any deposit made in full payment if full payment is not received 2 weeks prior to the show date. It is understood that any projection/quotation on attendance is based on previous shows or like shows from other venues. Management offers no guarantee on attendance and Exhibitor's performance. No subletting of booth space is permitted or Exhibitor's right to exhibit will be forfeited without refund. No taping, nailing, or painting on the walls or floors. Management reserves the right to change the exhibit hall, alter the floor plan, and re-assign if deemed necessary for the commonwealth of the show. If the Exhibitor accepts a re-assigned space for any reason, the fulfillment of this contract is deemed completed with no other recourse possible. Management has the right to rent space to firms, companies, individuals, and organizations engaged in similar or competitive business to exhibitors. Management will not offer exclusive rights to any exhibitor. Management reserves the right to refuse business to anyone or organization. Loud music is not allowed. Violator will be warned once and via ejected on second violation. Due to the nature of the trade show, business exhibitors assume full obligation of this contract including the full balance due once the contract is signed. Cancellation for refund request must be in writing and arrived at management's office at least 180 days prior to the event date. Otherwise, no other cancellation refund, or exchange is allowed.
